

1. NIRAPAD at a Glance

1.1. Background of NIRAPAD

Set up in 1997 to bring the information gap and strengthen the abilities of development organization and community to reduce disaster risk, NIRAPAD is an open coalition working in Bangladesh. CARE Bangladesh along with its disaster management partner NGOs established the coalition. All 23 members under the coalition have been working in the high risk areas of Bangladesh since long to reduce the risk of disaster on livelihood security of vulnerable household. And, each of the member organization has included disaster management as an integral component of their ongoing development program and earmark resources in their annual budget.

NIRAPAD acts as a facilitator and as a depository of all disaster related information, maintains inventory of skilled personnel, impulses awareness building in disasters, monitor disasters & disaster preparedness activities and maintain coordination with member organizations, non-member NGOs, social organizations, government agencies, etc.

A constitution and strategic plan has been developed for NIRAPAD by its member organizations. The constitution and strategic plan clearly states the vision, mission, activities and management procedure of the network. The vision, mission and strategies of NIRAPAD are as follows:

1.2. Vision

“To achieve DRM agencies following, integrating and mainstreaming the national and International Drivers and progress towards risk-free Bangladesh.”

1.3. Mission

“Provide support and services to the DRM agencies for strengthening progress in the field of DRM and CCA”

2. Strategies 2010

Strategic plan helps an organization to maintain its focus and competitiveness in the evolving context. It provides a basis for external and internal analysis; identify future course of actions, determine effective and efficient ways to proceed, and formulate winning strategies. In the changed scenario of trend and frequency of disasters as well as the threat of Climate Change, new strategy will guide NIRAPAD to become a knowledge leader and facilitator in DRM and CCA for Bangladesh.

The strategies identify as the means of attaining the goals, objectives and materializing the mission of NIRAPAD, these are:

2.1. Strengthen the knowledge management process on DRM & CCA field at national level

Given the need of the sector, it will be the strategic focus of NIRAPAD to feed the sector with disaster related information such as information on disaster situation, technologies, technical and resource persons, preparedness of public, private and NGO sectors in disaster response and mitigations, disaster related support and services available, etc.

2.2. Provide the capacity development support for integrating DRM & CCA to organizations

To transform NIRAPAD as an effective and efficient network, all stakeholders felt the importance for further capacity building of NIRAPAD so that it can play increased roles and responsibilities in disaster risk reduction in the changed situation.

2.3. Coordinate Humanitarian advocacy at the national level

Being a networking organization, the scope of NIRAPAD should be embodied in advocacy and lobby with the policy makers, donors, corporate sectors and others for greater attention and resources allocation in disaster risk reduction. NIRAPAD also makes a strategic drive to build public awareness on new and more challenging issues like climate change.

8. Implementation Strategies

Based on the above goal and objectives NIRAPAD developed implementation strategy and provide resource mobilization commitment from their own initiatives. The implementation strategy in the three areas of knowledge management, capacity building and humanitarian advocacy are as follows;

8.1. Knowledge Management

Knowledge Management is one of the major initiatives taken under the Organizational Capacity Building of NIRAPAD. It conducted knowledge management activities regularly and following systematic sequence. Knowledge management activities have done through Information collection & sharing (web), Monitoring & evaluation, Lesson learning, Documentation, Research, Publications, Archive and mapping throughout the year.

8.2. Capacity Development

Capacity development to the wider stakeholder in disaster management is another implementation strategy where NIRAPAD provided its effort for support to members as well as other organization and individual. In the project period NIRAPAD developed module and trained wider stakeholder, provide tailor made training module development support, technical support in disaster management to other organizations, conducted training on different issues, organized different workshops and support in developing bangle disaster materials for others.

8.3. Humanitarian Advocacy

NIRAPAD as a network significantly expand the information available to its constituent organizations through publications, situation report and newsletter to develop common consensus and influence policy makers. The member organizations are learning from each-other and by utilizing each-others skills, resources and able to gain flexibility, strength and efficiency by the technical assistance of the network. Also prioritize public education for mass awareness through partnerships with NGOs. Provide humanitarian advocacy development support to others for developing strategy, advocacy workshops organize and build wider coordination.

9. Progress of Activities (2010)

The following are progress based on the each strategic objective;

9.1. Knowledge Management

Organize LLW: A workshop on “Disaster Resilience through Livelihood-Centered Approach: Learning and way forward” was held on 20 October 2010 at the conference room, BRAC Center Inn, Gulshan, Dhaka. It was organized by NIRAPAD support from DFID and Practical Action in partnership with 3 local NGOs named Samaj Kallyan Sangstha (SKS), Uttara Development Program (UDP) and Gono Kalyan Sangstha (GKS).

NIRAPAD has worked as a technical partner in the evaluation of the project “Disaster Resilience through Livelihood-Centered Approach”. As Practical Action is implementing the livelihood-centered disaster risk reduction project, the evaluation of the project has provided the opportunity to NIRAPAD to gather knowledge on approaches, operational activities and opportunities for Practical Action. After completion of the evaluation a workshop was organized to share the lesson learned of the project and recommendations from different sectors. As peoples from wide range of sectors have attended the workshop so that was a very fruitful and participatory discussion to way forward.

Situation Monitoring and Reporting: Situation Reports were prepared by NIRAPAD daily and monthly basis to cover the all disaster and disseminate to wider stakeholders. From June to October, 2010 total 29 situation reports were sent to more than two thousand stakeholders. Major situation reports covered disaster like- Nor'wester, depression, flood, Tornado and Bushfire, river bank erosion etc.

Along with the situation update, NIRAPAD tried to distribute information regarding humanitarian activities and fund and aid support.

Publication and dissemination of daily situation report is firmly recognized by Wikipedia as valid information source of disaster.

Evaluation of the Project on “Community Based Disaster Risk Reduction in Bangladesh” of Concern Universal

The Community Based Disaster Risk Reduction (CBDRR) in Bangladesh Project, funded by the Cordaid as a follow through of the previously implemented projects. Dhaka Ahsania Mission (DAM) was implementing partner of the project. The project was implemented in four districts (Patuakhali, Barguna, Mymensingh and Jamalpur) in two geographical locations one is Cyclone and another one Flood prone region. The purpose of the evaluation was to gain greater insight into and understanding of the process, relevance, impact, sustainability and effectiveness of the Concern Universal CBDRR project and the recommendations for future DRR project. The consultants of the project were Zahid Hussain and Shashanka Saadi and Kazi Shahidur Rahman. The evaluation of community based disaster risk reduction was done through various steps as data collection. After that triangulation of collected data was done through KII, observation, interactive group interview, staff consultation and document review.

A study Report on “Survival Strategies of Char Land Women from Climate Change Hazards in Bangladesh” of Planning Commission

A Research project for supporting Planning Commission was also conducted by NIRAPAD.

The study on Survival Strategies of Char Land Women may be useful to find out the problems and challenges of the Char land women and to explore the best practices of survival strategies with involvement of local knowledge for the Char land women during hazards.

The study has done through data collection and analysis of those data. Different tools were applied for data collection as, group discussion, interview of people and Key Informants’ Interview (KII) and different PRA tools. This study may help one to understand the activities of women to manage their scarce economic resources of Kunderchar of Shariatpur District and Charwadel of Patuakhali District.

Preparation of a handbook on “Women Leadership in Disaster Risk Management” and roll out of the handbook of Oxfam-GB

NIRAPAD has also provided technical support to Oxfam-GB, Bangladesh through a project named “Women Leadership in Disaster Risk Management Handbook” and to roll out of the handbook. To roll out of the handbook Dhaka Ahsania Mission (DAM) and FIVDB, Sylhet is working as a partner with NIRAPAD. NIRAPAD has conducted a ToT for the trainer of DAM and FIVDB. A number of training has also organized by NIRAPAD for DAM and FIVDB to train up their school teachers to roll out the handbook at grass root level.

A national level workshop was held to share the handbook at national level. At the national sharing workshop Mr. Kazi Shahidur Rahman and Tahmina Rahman was presented the handbook. The recommendations from the workshop at national level have incorporated to the final handbook.

9.2. Capacity Development

Capacity development process continues through different project where NIRAPAD provide technical support. In the year of 2009-10 NIRAPAD has accomplished a number of projects of different organizations for their capacity development. Description of those capacity development activities are given under.

Comprehensive Disaster Management and Climate Change Issues for World Vision Bangladesh

To build capacity of the staff of Area Development Programme (ADP) and to demonstrate some of the viable DRR measures in risk prone (Flash flood, seasonal flood and Cyclone) areas, World Vision, Bangladesh has decided NIRAPAD as technical partner to well equipped their staffs

with DRR technique and tools so that they can contribute in mainstreaming DRR in their common development programmes. In that journey of technical assistance NIRAPAD has provided support to the staffs of World Vision to better understand disaster risks and climate change threats and their consequences on communities and program interventions, plan for preparedness and response to minimize impacts of disaster on communities and Plan for mainstreaming DRR in development programs. For this purpose a number of training has conducted by NIRAPAD in Dhaka and Bogra to make the staffs of WVB to better understanding about DRR and CC.

Comprehensive Disaster Risk Management for CARE-Bangladesh

Food Security for Ultra Poor Project in the Haor Region (FSUP) Project of CARE Bangladesh - Support to reduce extreme poverty, food insecurity and vulnerability for the Ultra poor household especially women with a focus on long term sustainable livelihoods. The purpose of CARE Bangladesh initiatives is to assist the victims of natural disasters in Bangladesh through effective and efficient humanitarian assistance. To achieve their objective NIRAPAD has provided technical assistance to CARE-B to build capacity of the staff of FSUP Project on the issues and activities planned around the DRR component of the project for better understanding on the issues and implementation of interventions maintaining standards and technicalities involved. For this purpose NIRAPAD has organized training for CARE-B staffs at Sylhet.

Training Manual for FSUP-H staffs of CARE-B Training for CARE-Bangladesh

CARE, Bangladesh has taken a project to prepare a number of training modules for their staff to make people capable to face disaster and NIRAPAD has provided technical support to prepare those training module.

NIRAPAD has prepared a total of five (5) training module for CARE- Bangladesh staffs. Those modules are of different user group as well as for different beneficiary group. Among those modules, Community Risk Assessment (CRA) module was for VDC EKATA; Disaster Risk Reduction (DRR) module was for SMC & Teacher of CARE-B; DRR module was for VDC and EKATA of CARE-B; Early warning (EW) module was for VDC & EKATA of CARE-B and DRR Module for UDMC and UP member of CARE-B.

9.2 (a) Member Organizations Capacity Building

ECB Accountability Training on Good Enough Guide The “Good Enough Guide” was prepared under Emergency Capacity Building (ECB) Project. NIRAPAD has provided support to convert the GEG guide into Bengali. ECB project has organized accountability training on GEG and provided opportunities for NIRAPAD staff as well as staff of partner organization of

NIRAPAD. As part of the training process staff of two partner organizations of NIRAPAD also got training on GEG accountability.

Community Mobilization to Promote Social Change in 34 Riverbank Upazilas of Seven Jamuna District

The project is funded by UNICEF and NIRAPAD and RIC has started the journey to implement the project. Here in this journey NIRAPAD has also added its member organizations i.e. Basic Unit for Resources and Opportunities (BURO, Bangladesh), Unnayan Sangha (US), Manab Mukti Sangstha (MMS), National Development Program (NDP), Uttara Development Program Society (UDPS), SKS Foundation and Gana Unnayan Kendra (GUK). The staff of the above partner organizations has got training on community mobilization to promote social change.

Women Leadership In Disaster Risk Management Handbook and Roll out of this handbook

NIRAPAD has prepared a handbook on women leadership in disaster risk management, a project of Oxfam-GB, Bangladesh. In this journey NIRAPAD has added its member organization i.e. FIVDB and included the Dhaka Ahsania Mission (DAM) as a partner of the project. After completion of the handbook NIRAPAD has organized ToT on the handbook of those two organizations. NIRAPAD also organized nine batch training with assistance of FIVDB and Dhaka Ahsania Mission for primary school teacher of these organizations.

9.3.Humanitarian Advocacy

Disaster Resilient Haor: Flood Risk Reduction Activities in Sunamgonj of CARE-Bangladesh

NIRAPAD has provided advocacy support to CARE-Bangladesh under “Flood Risk Reduction Activities in Sunamganj (FRRAS)” project. A national sharing Workshop was held at the completion phase of the project on March 23, 2010 at Spectra Convention Center, Gulshan, Dhaka, Organized by NIRAPAD and CARE-B. Participants were international and national disaster management practitioners, climate change and water resource management experts drawn from both national and regional institutions. The purpose of the national workshop was to share the lessons learned of the FRRAS project for sustainable DRR programming in future. The advocacy workshop concluded with recommendations for local community, government body and stakeholder working in the area.

Swelled sufferings: challenges after one year of Aila of ECB Project

Network for Information, Response And Preparedness Activities on Disaster (NIRAPAD) and the Emergency Capacity Building (ECB) Project, a consortium of six international NGOs including Oxfam, CARE, Catholic Relief Service, Concern Worldwide, World Vision, and Save the Children organized an Advocacy Campaign on “Cyclone Aila: Ensuring Entitlement for the Disaster Affected People” on 21 May 2010. International and national disaster management practitioners, experts from GO, NGO and Donor organizations along with journalists working

in international print and electronic media has participated this discussion. In this campaign the Launching Ceremony of “Testimony of Journalist on Swelled Sufferings of Aila Hit People in One Year” has taken place. Mr. Mihir Kanti Mazumder, the Honorable Secretary to the Ministry of Forest and Environment, and Mr. Monjurul Ahsan Bulbul, CEO and Editor in chief of the Baishakhi Television, unveiled the cover of the testimony. For wider dissemination and raising awareness to the wider community the discussion of round table discussion was published in The Daily Star on May 22, 2010.

The Policy dialogue titled ‘Swelled sufferings: challenges after one year of Aila’ was held on 23 May 2010 at CIRDAP Auditorium, Dhaka, Bangladesh. The policy dialogue has formulated a policy framework for the welfare of Aila affected people to mark the one-year of Cyclone Aila. The Emergency Capacity Building (ECB) Project, a consortium of six international NGOs including Oxfam, CARE, Catholic Relief service, Concern Worldwide, World Vision, and Save the Children—in association with the Campaign for Sustainable Rural Livelihoods (CSRL)- a network of 200 local, national and international development and civil society organizations and European Commission Humanitarian Office’s partner organizations jointly organized the dialogue. People of AILA affected community also attended the policy dialogue and presented the situation of the area after one year of AILA. That policy brief sets forth five specific recommendations to the government, development partners and international communities to ACT NOW in order to appease the sufferings of the Aila affected people. The policy dialogue also endow with suggestions and recommendations by participation. For wider dissemination and raising awareness to the wider community the discussion of round table discussion was published on The Daily Star, The Daily Shomokal, The Daily Bangladesh Shomoy, The Daily New Age, The Daily Ittefaq on 24 May, 2010. A mime show also published on The Daily Ittefaq, The Daily Star and on The Daily Kaler Kantha on 25 May, 2010 titled “Are we human?” to mark One Year of Aila.

Education in Emergency-A National Priority of UNICEF

NIRAPAD has provided advocacy strategy support to the UNICEF and its’ consortium as part of technical support to other organization. That was a high end strategy for the major humanitarian stakeholders in Bangladesh for developing their advocacy capacity.

Education in Emergency (EiE) is a non-negotiable issue. Unfortunately, yet it is not a priority for the disaster managers. It is intimately connected with Child Protection in Emergency (CPiE). Protection issues for students can be addressed to a large extent if Education in Emergency is ensured. It also prevents violation of children’s rights to education and creates scope for overcoming trauma. In this regard, Bangladesh has unique experience during AILA emergency.

Preparation of CC and DRR Policy for Northwest Bangladesh and policy dialogue at national level

NIRAPAD has provided advocacy strategy support to the RDRS as part of technical support to the organization. This is a high end strategy for RDRS working in Northwest Bangladesh for developing their policy as well as advocacy capacity.

For the purpose of preparation CC and DRR policy for RDRS under the project of “Alleviating Poverty through Disaster Risk Reduction in North West Bangladesh” NIRAPAD has conducted four (4) workshops at community level in Hatibandha, Shimulbari, Kaliganj and Ramna Federation and two regional level workshops is conducted with RDRS program team at Rangpur. The workshops aimed to define advocacy issues for RDRS based on review of its policies on poverty, disaster and climate change and reorient RDRS policy centre through addressing claims of the communities vulnerable to disaster and climate change. Finally a national level policy dialogue was conducted to bring the policies inconsideration of national level.

Network for Information, Response And Preparedness Activities on Disaster (NIRAPAD) and RDRS (Rangpur Dinajpur Rural Services) organized a policy dialogue on “Climate Change (CC) and Disaster Risk Reduction (DRR) Policy” on 29 December 2010 at Meghna Hall, BIAM Foundation, Dhaka. The dialogue was also held to present a project titled ‘Alleviating poverty through disaster risk reduction in North-West Bangladesh’ co-funded by the European Union and Dan Church Aid. Participants were international and national disaster management practitioners and experts drawn both from Government Organizations, Non Government and Donor organizations. The policy Dialogue was endowed with recommendations by participants. the scope of the workshop is defined by the specific needs of RDRS intervention in Bangladesh and has been truncated to cope with the resource constraints of the organization and time constraints. After recommendations from national level the final CC and DRR policy has been prepared.
